Important note: The steps to develop or update the program are initiated only after obtaining the initial approval of the Standing Committee for Postgraduate Studies

After the topic was given to the Standing Committee for Postgraduate Studies and issued The Standing Committee's decision to approve the programme in principle begins the College Develop the programme and follow the model of the Programme Building Guide.

Note: a period of time not exceeding six terms has been set from the standing committee's decision for postgraduate studies, preliminary approval of the request to develop or update a program until its establishment.

In the course of preparing the college for the program and accomplishing (90%) of it is done letter from the College to the Deanship of Postgraduate Studies with the approval of the Council department and College on the names of three external arbitrators with attachment CV of each arbitrator and table showing the arbitrator's name and specialization Destination for presentation to the Standing Committee on Postgraduate Studies.

After approval of the names of the arbitrators by the Standing Committee on Postgraduate Studies, the names of Select number 2 per program and here the college can send the program Arbitrators for Arbitration.

Following arbitration, the college will send a letter to the Deanship of Postgraduate Studies by decision. Following arbitration, the college will send a letter to the Deanship of Postgraduate Studies by decision. The department and college boards approve the program and a copy is sent from the PDF courtesy program after arbitration, with the importance of inserting a table showing complete satisfaction of arbitrators' observations and reports before and after arbitration, with reference to page numbers where the modification is to be rendered and studied by the Program Committee.

Mechanism for developing or updating a postgraduate program

Obtaining program accreditation from the Education and Training Assessment Authority or from an international authority approved by the Authority: 1) Bachelor's program for Master's Degree approval.

2) Master's Program for PhD Approval.

- Adherence to the Saudi Standard Classification of Educational Levels and Discipline. -Adherence to Saudi Arabia's National Qualifications
Framework. Aligned with job market needs in agreement with the Ministry of Human Resources and Social Development.

The department fills the application form for develop or update the program. The form will be presented on both councils the department and the college. After the approval a letter from the college will be sent to the deanship of the postgraduate studies by the decision of both councils, and the request for preliminary approval for the development or update of the program
